INFORMATION ON TAX COLLECTION FOR 2014-2015**

Enclosed is your 2014 Property tax bill. Please return the tax bill to the Town Treasurer's office if you are not the owner of the property described on the tax bill.

Did you receive a Lottery & Gaming Credit for your principal residence? If not, contact your local treasurer to see if you qualify. Also, please inform the treasurer if the property ceases to be your principal residence.

**TO AVOID WAITING IN LINE**

**PLEASE USE THE MAIL FOR PAYMENT.** We will honor the postmark date.  
**IF YOU PROVIDE A STAMPED, SELF-ADDRESSED ENVELOPE, YOUR RECEIPT WILL BE RETURNED TO YOU.**

Write checks for the exact amount of the Tax Bill. A separate check must be made out for the dog tags. We cannot make change for overpayments. A refund check will be mailed to you after the next Town of Rubicon Board meeting. To avoid waiting for your refund check, request your mortgage company to write the check out for the exact amount on your tax bill. Your tax bill is to be made out to: **TREASURER, TOWN OF RUBICON.**

Real Estate tax payments remain the same, full or first half installment payments are due by January 31st, 2015. **DO NOT PAY THE TOWN TREASURER FOR THE SECOND installment .It is due directly to the DODGE COUNTY TREASURER by July 31st, 2015.**

Dog license(s) (new & renewal) are due for the year 2015 at real estate tax collection time. **A separate check must be made out for the dog license(s).** Wisconsin law requires that all dogs must have rabies inoculations and must be licensed annually. The required fee for each NEUTERED male dog and SPAYED female dog is \$5.00, while a \$10.00 fee is required for each unneutered male or unspayed female dog.

**Please enclose a self-addressed stamped envelope for the return of tag and receipt.**
